Welcome to the 2026 Provincial Aesthetics (30) Competition. Congratulations on participating in such an exciting and rewarding competition!

**Models for all competitions will be provided by the competitor. Please see the Model Requirements section for important details.**

During the competition you will be judged in the following areas:

- Professional presentation
- Technical skills
- Organizational skills
- Communication
- Product knowledge & control
- Sanitation and complying with health and safety
- Body Therapy Treatment (Female Model)
- Advanced Facial (Female Model)
- Manicure: Galaxy Themed (Female Model)
- Creative Makeup: Galaxy Themed (Female Model)

#### **Orientation for Competitors:**

Competitors are to bring a copy of the Contest Description, Project and any other documents pertaining to the Aesthetics competition. During the competitor orientation, you will have the opportunity to familiarize yourself with the equipment, products and tools. Competitors will have the opportunity to ask questions at this time.

#### **Tasks and Checkpoints:**

You will be given a specified time for each task. Judging is done throughout each task, so you will need to be aware of these **CHECK POINTS** indicated in your instructions. It is the competitor's responsibility to ensure that judges check the models prior to commencing any treatment.

All tasks must be finished within the given time. Other than judging time, no extra time will be granted.

**Note:** If you are in doubt about any other tools or equipment you wish to use, check with the chair of the committee **prior** to the competition date. Each test must be performed using the provided number of towels specified below. You do not have to use all of the supplies/towels, however, you cannot use more.

\*Competitors may choose not to use all towels but cannot use more than the prescribed amount for each competition component.

\*Points will be awarded throughout each test for professionalism and compliance with occupational health and safety.

**UNIFORM** - Throughout the competition, the competitor must wear a black colored professional uniform of their choice (scrubs are acceptable) with black closed-toed shoes and black socks that are no shorter than ankle height. **Skinny jeans, leggings and shoes with no socks are not considered as the required uniform and points may be deducted where necessary.** No jewelry is to be worn on the hands and wrists, and no long jewelry that may come in contact with the model (i.e. dangling necklaces). Hair must be kept up and out of the competitors' face. Competitors nails must be free of polish/nail extensions.

### MODEL REQUIREMENTS

- Must be female between ages of 18-35.
- Free from sensitivities or allergies.
- Available for the entire day.
- Any piercings must be removable, no permanent jewelry, no tattoos on chest/shoulder area/face
- Willing to receive services from another competitor.

- Free of any skin diseases and disorders, and in general good health with no contraindications, including epilepsy or diabetes.
- Models will have healthy hands and nails, with no artificial nails, bitten nails or recent removal of, and the free edge must past the fingertip.
- Models must be present prior to the start time, each day of competition – must present with clean, natural nails on hands, free of varnish, and no makeup.

**\*Please Note:** Models will be supplied by the competitors and approved by the committee. Competitors will not be working on their model. Failure to meet the criteria will result in the disqualification of the competitor.

#### Design Area & Coverage Requirement

Required makeup area:

*face, front of neck, upper chest (décolleté) extending ~2 inches below collarbone. Shoulders and arms not included.*

Coverage Requirement:

*At least 75% of the design area must be visibly covered with Galaxy-themed makeup; 25% may remain bare or softly blended for balance. **Acceptable:** Full face + partial neck/décolleté, or both sides of face/neck with small bare chest section. **Not acceptable:** Small decorated sections (e.g., only eyes/forehead) leaving large bare patches.*

- Competitors must achieve  $\geq 75\%$  coverage
- Blend/fade zone below collarbone must look intentional and complete

#### Prohibited Materials

*Professional makeup mediums (including wax, latex, gels, creams, body paints, cosmetic glitter) are permitted.*

*Stick-on embellishments and non-makeup items are strictly prohibited on face/neck/décolleté. This includes rhinestones, gems, sequins, pearls, feathers, foil, craft glitter, or other raised materials.*
